

**The Tournament Director/Assistants shall be responsible for schedules of games and pairings in their respective events. They shall also keep entries submitted to them by different Bureaus participating in the tournaments. They shall arrange venues and determine initially eligibilities of players and protest filed before them. They shall also monitor the standings of the teams and submit the same to the Technical Committee upon request of the latter or at the termination of the Tournaments.**

**On the other hand, the Technical Committee shall be the over-all overseer of the entire competitions. It shall be the final judge to resolve eligibility of players and protest elevated to it by the Tournament Directors. It shall also be responsible for submission of the over-all result of the tournaments. It shall also be responsible for the acquisition and distribution of awards to the winners and to perform such other functions that normally belongs to it.**

**This Order takes effect immediately and revokes automatically upon the termination of the tournaments.**
