Amendment to Special Order No. 79
Series of 1983 Creating the Task
Force on Foreshore Areas

In the interest of the service and in view of the result of the concluded workshop on the management and disposition of foreshore areas, Special Order No. 79 Series of 1983 is hereby amended as follows:

1. The Task Force on Foreshore Areas shall be composed of:

- 2. The Task Force shall perform the following functions:
 - 2.1 Review and finalize the output/result of the Workshop and endorse the same for the Minister's consideration and/or approval.
 - 2.2 Formulate the implementing guidelines to effect the resolutions arrived at during the workshop.

- 2.3 Undertake necessary study and formulate recommendations on:
 - questions of jurisdiction over foreshore area
 - mechanics of renewal of fishpond leases previously granted by BL
 - mechanics of turn-over of the improvements after the expiration of the lease contract
 - maximum limit for all other prospective leases aside from FLA's
 - appraisal value standards of foreshore areas
- 3. To pursue these activities, the Task Force shall be supported by a Secretariat based at the Planning Service to provide technical and administrative assistance. It shall be composed as follows:

- 4. The Task Force Chairman is authorized to organize meetings and call upon its members in line with the aforementioned functions. He shall report directly to the Assistant Secretary for Legal Affairs.
- 5. The members of the Task Force and the Secretariat are also authorized to collect expenses including honorarium in the performance of their functions subject to usual accounting rules.

This Order shall take effect immediately and shall remain in force unless otherwise revoked.
