Furthermore, in consonance with the previous Memeorandum of Agreement signed by the heads of all participating agencies dated October 7, 1982, funds shall be provided for the technical and administrative operations of the said bodies, subject to the availability of funds. The member agencies shall make available the amount of ₱534,600.00 for the CY 1984 as follows:

Office of the Minister	120,000.00
Bureau of Fisheries and Aquatic Resources	70,800.00
Bureau of Forest Development	76,200.00
Bureau of Lands	50,400.00
Bureau of Mines and Geo-Sciences	81,600.00
Fishery Industry Development Council	51,600.00
Phil. Fisheries Development Authority	84,000.00

The Philippine Fisheries Development Authority (PFDA) shall act as fund administrator for the aforesaid amount to be released on a quarterly basis. It shall supervise the release of such funds intended to defray the necessary expenses of the MNR-ASEAN Coordinating Committee and the MNR-ASEAN Secretariat for its effective and efficient operations. However, such expenses/expenditures to be incurred shall be subject to the approval of the Coordinating Committee.

This Order shall take effect immediately and shall remain in force until revoke in writing.
