Compliance with Executive Order No. 1039 Creating Wood Industry

Development Authority (WIDA)

In compliance with Executive Order No. 1039 dated 10 July 1985, creating the Wood Industry Development Authority, and in order to effect a smooth transfer of functions and powers of the Presidential Committee on Wood Industry Development, and of the Bureau of Forest Development pertinent to the regulations, control and supervision and development of forest-based industry, an inventory of the balances of appropriations, records, equipment, properties and personnel of the Presidential Committee on Wood Industry Development, as well as in the following Divisions, Sections and Units of the Bureau of Forest Development shall be conducted:

## National:

- 4. Forest Utilization Division

## Regional:

- 1. Forest Egnineering and Infrastructure Section
- 2. Forest Protection and Law Enforcement Section
- 3. Timber Management Section
- 4. Forest Utilization Section

## District:

- 1. Forest Engineering and Infrastructure Unit
- 2. Forest Protection and Law Enforcement Unit
- 3. Timber Management Unit
- Forest Utilization Unit



Balances of appropriations, records, equipment, properties and personnel in all other Divisions, Sections, and Units of the BFD whose functions are related to those which are provided for in Section\$ 2 and 4 of Executive Order No. 1039 shall likewise be inventoried.

For this purpose, a task force is hereby created composed of the following, to wit:

The Task Force is hereby authorized to call upon any Unit, Section, Division, Service or personnel in the Ministry of Natural Resources and the Bureau of Forest Development and Presidential Committee on Wood Industry Development to effect immediate and expeditious compliance with this Order.

It is understood that the processing of all papers, documents and other transactions in the Bureau of Forest Development and the Presidential Committee on Wood Industry Development related to the powers and functions of the Wood Industry Development Authority shall continue to be done and acted upon by the affected Divisions, Sections and Units provided that such papers, documents and transactions that are normally coursed thru the Directors of Forest Development and Presidential Committee on Wood Industry Development shall now be coursed directly to the Chairman of the Wood Industry Development
