

As such, they shall be entitled to claim reasonable transportation expenses, daily allowances of ₱40.00 for each actual tournament and practice game and shall be provided with free uniforms pursuant to MC #1271 of the Office of the President, chargeable against their respective Bureaus/Offices' Allocation of Funds and subject, furthermore, to the usual accounting and auditing rules and regulations.

This order takes effect immediately and shall remain in force until the duration of the tournament.
