SUBJECT: Transfer of serviceable vehicles to WIDA Management areas from BFD Regional Offices.

Pursuant to the pertinent provisions of MNR General Memorandum Order No. 2 and MNR General Memorandum Order No. 4 dated October 1985 and December 1985, respectively, and in view of the urgent need to enhance the mobility and effectiveness of WIDA Management area managers and personnel in performing their functions, duties and responsibilities, the following serviceable vehicles are hereby transferred from the BFD Regional Offices to the WIDA Management areas as indicated herein-below:

From BFD Region 1 to:

WIDA Area No. 1, Vigan, Ilocos Sur - 1 pick-up, SBG 147
WIDA Area No. 2, Baguio City - 1 Pick-up, Toyota Hi-Lare

From BFD Region 3 to:

WIDA Area No. 10, San Fernando, Pampanga - 3 Pick-ups, Toyota Hi-Lux From BFD Region 4 to:

WIDA Area No. 11, Metro Manila - Toyota Hi-Lux, DDB-143

From BFD Region 5 to:

WIDA Area No. 17, Naga City - 2 Pick-ups, Toyota Hi-Lux WIDA Area No. 18, Legaspi City - 2 Pick-ups, Toyota Hi-Lux

From BFD Region 8 to:

WIDA Area No. 21, Calbayog City - 1 Pick-up, Toyota Hi-Lux WIDA Area No. 22, Tacloban City - 1 Pick-up, Toyota Hi-Lux

From BFD Region 10 to:

WIDA Area No. 25, Cagayan de Oro City - 2 (1 Toyota Land Cruiser and 1 Toyota Hi-Lux)

WIDA Area No. 26, Butuan City - 2 (1 Toyota Land Cruiser and 1 Toyota Hi-Lux)

WIDA Area No. 27, Prosperidad, Agusan
del Norte - 2 (1 Toyota Land Cruiser
and 1 Toyota Hi-Lux)

From BFD Region 12 to:

WIDA Area No. 33, Isulan, Cotabato - 2 (1 Toyota Land Cruiser and 1 Toyota Hi-Lux:)

WIDA Area No. 34, Cotabato City

- 2 (1 Toyota Land Cruiser and 1 Toyota Hi-Lux)

WIDA Area No. 35, Iligan City

- 2 (1 Toyota Land Cruiser and 1 Toyota Hi-Lux)

This initial transfer is without prejudice to the actual number of vehicles entitled for WIDA field management areas based on actual computations to be made considering the ratio of WIDA-BFD jurisdiction in every region as spelled out in MNR General Memorandum No. 4 and amendment/s thereto. Such subsequent transfers shall be effected after proper consultations with both BFD and WIDA on the appropriate number under the foregoing basis.

This Order takes effect immediately. The concerned WIDA area managers and BFD Regional Directors should report within ten (10) days of their compliance herewith.
