- 3.3 To formulate and design training programs and academic curricula for the IPAS.


The Task Force shall provide the undersigned and the Director for Protected Areas and Wildlife Bureau all of its reports, outputs and accomplishments.

The Task Force shall avail itself of the assistance of all officials and employees under the Department and its attached agencies in the official discharge of its functions.

The Task Force shall work closely with The Haribon Foundation for the Conservation of Natural Resources, a non-governmental organization dedicated to environmental and tribal concerns, in the preparation and development of the IPAS.

The Task Force shall charge all its travelling expenses, per diems and other allowances to the Department, subject to the availability of funds and the usual accounting and auditing regulations.

This Order takes effect immediately and shall remain in force unless, otherwise, amended or revoked in writing.

In this connection, the Committee shall thereafter immediately submit its recommendation as to whether or not the said contract between CRMF and the DENR be continued.

The Committee is hereby authorized to avail itself of the services of any employee of the Department and/or any of its Bureaus and Offices in pursuance of its tasks.

The Committee is also authorized to review/evaluate all records of the Calauit Project, as well as those at the Conservation and Resource Management Foundation, Inc., Makati, Metro Manila, pertaining to the Project.

The members of the Committee shall be entitled to reasonable traveling expenses, per diems and other allowances in accordance with existing COA regulations and subject to availability of funds, chargeable against any available funds of the DENR.

This Order takes effect immediately and cancels, revokes or amends orders or instructions inconsistent herewith.
