SUBJECT: Creation of a Council on Security on the Ministry of Natural Resources.

In the interest of the service, and in order to provide adequate security for buildings, property, personnel, documents communications, processes and operations in the Ministry of Natural Resources and its Bureaus and Offices, a Council on Security is hereby created composed of the following:

Specifically, the Council shall have the following functions and responsibilities:

- 1. Acts as adviser to the Minister and the Heads of Bureaus and Offices of the Ministry on security matters;
- 2. Provides security for buildings, properties, personnel, documents, communications, processes and operations of the Ministry of Natural Resources and its Bureaus and Offices, and communications facilities, and supervises and conducts fire drills;
- 3. Formulates policies, and develops and implements plans and programs to provide necessary security measures;
- 4. Maintains liaison and coordinates with the New Armed Forces of the Philippines, NICA, NBI, INP, and National Law Enforcement Coordinating Council and government fire fighting agencies;
- 5. Conducts regular security orientations and briefings among personnel;
- 6. Conducts regular security surveys and inspections of MNR Bureaus and Offices and gathers information on security matters and proper monitoring thereof;
- 7. Monitors violations of Natural Resources laws and regulations;
- 8. Conducts personal background checks and assists in securing required clearance for employees and job applicants;
- 9. Meets regularly once a month and whenever necessary to assess security situations; and submits monthly reports, and whenever needed, thereon to the Minister;
- 10. Activates all Security Units in the Regional Offices, which shall be placed under the supervision of the Regional Director; and
- 11. Performs such other functions as may be assigned by the Minister from time to time.

To effectively carry out there functions, Private Security Units hired by the agency as well as agency Security Guards are hereby placed under the supervision of the Security Officer of the Bureaus/Offices concerned and under the Chairman Council on Security in the case of Office of the Minister (OMIN).

This Office, as well as the Heads of Bureaus and Offices under the MNR, are hereby directed to provide operating expenses and other allowances to the Council and its members chargeable against their respective funds.

This Order takes effect immediately and shall remain in force until revoked in writing by the undersigned.
