SUBJECT: AUTHORIZING THE "COMMUNITY-BASED SMALL SCALE UTILIZATION AND MANAGEMENT OF COASTAL/MANGROVE FOREST IN PALAWAN PROJECT TO HOLD A SYMPOSIUM-WORKSHOP ON MANGROVE RESEARCH, ENVIRONMENT, POLICY AND INFORMATION ON DECEMBER 15-17, 1989 AT THE DA-PIADP TRAINING SITE IN IRAWAN, PUERTO PRINCESA, PALAWAN.


In pursuance of the tasks and objectives of the "Community-Based Small Scale Utilization and Management of Coastal/Mangrove Forest in Palawan Project" as provided for in the approved Annual Work Plan, the project is hereby authorized to hold a Symposium-Workshop on Mangrove Research, Environment, Policy and Information on December 15-17, 1989 at DA-PIADP Training Site in Irawan, Puerto Princesa, Palawan.

The Symposium-Workshop aims to inform the participants on (1) the environmental and economic benefits derived from mangrove resources; (2) the necessity of protection and sustainable utilization thereof; (3) the existing laws, regulations and policies intended for the protection and proper management thereof; and (4) the current programs of the government for the protection and management of mangrove resources in Palawan and other places. Likewise, the workshop-symposium aims to consult the participants on: (1) state of mangrove resources in their respective areas, (2) the implementability of existing mangrove laws, regulations and policies therein, and (3) the needed laws, regulations, policies and programs for the protection and proper management thereof. Consequently, through this symposium-workshop a sound policy and program recommendation shall be achieved.

The Symposium-Workshop shall be attended by barangay chairmen, and city officials of Puerto Princesa City representatives from government and non-government agencies and provincial officials of Palawan (see attached page).

All expenses to be incurred shall be charged against the Community-Based Small Scale Utilization and Management of Coastal/Mangrove Forest in Palawan Project, DENR-PIADP Upland Stabilization Project, and DENR-PIADP Land Survey and Titling Project, subject to usual accounting and auditing rules and regulations.

This Order shall take effect immediately.
