2. The team shall validate the reforestation accomplishment of TLA holders for CY-1988 using the Monitoring and Evaluation System (MES) developed by the FMB.

3. They shall coordinate with the Regional Executive Directors, Provincial Environment and Natural Resources Officers, Community Environment and Natural Resources Officers and PWPA representative concerned, and shall avail of the services of any field personnel and facilities necessary to carry out their activities.

4. They shall be entitled to reasonable transportation expenses, allowances and per diems subject to the usual accounting and auditing rules and regulations, chargeable against DENR funds.

5. Each team shall submit a report to the Undersecretary, Field Operations thru the FMB Director within seven (7) days upon completion of their field work.

6. The Coordinating Committee shall supervise, evaluate and analyze reports submitted by the team. It shall also prepare comments/recommendations based on submitted reports for submission to higher officials concerned.

7. The Secretariat shall consolidate reports and data submitted by the team. It shall also keep/maintain the files and records of the evaluation work.
