A PENRO/CENRO Conference-Workshop will be held on 26-29 April 1989 and 4-6 May 1989 for the Luzon and Visayas/Mindanao Group, respectively. This Conference aims to enhance understanding of major DENR programs specifically the National Forestation Program (NFP) and the Comprehensive Agrarian Reform Program (CARP).
