DENR SPECIAL ORDER NO. 422 Series of 1989

SUBJECT: Creating a Special Task Force for the Navotas-Malabon-Tenejeros-Tullahan (NMTT) River Pollution and Flood Control Program.

There is hereby created a Special Task Force whose function is to assist the Secretary and the Undersecretary for Environment and Research in the speedy implementation of the Framework Plan which was approved by the NMTT Steering Committee last 17 April 1989 and to implement the tasks assigned to the DENR in particular. In addition to the implementation of the Plan, the Task Force shall be responsible for the following specific tasks:

- 1. Coordination of the tasks of other government agencies involved in the Memorandum of Agreement of the NMTT Pollution and Flood Control Project;
  - 2. Regularly monitor river water quality;
- 3. Inspection of industrial firms within the river basin to determine compliance of pollution laws and submission of recommendations to the Pollution Adjudication Board (PAB); and
- 4. Prepare the technical, administrative, and budgetary requirements to support the Framework Plan and the specific tasks assigned by the undersigned from time to time.
