DISBURSING OFFICERS UNDER THE PALAWAN
IAD PROJECT.

In the interest of the service, Forester Pepito F. Pagador, Hector Y. Mauricio and Simon P. Leonor, Jr. as Special Disbursing Officers of the Upland Stabilization Project shall be authorized to handle Cash Advance to defray Personal Services, Maintenance and Other Operating Expenses and Capital Outlay funds for one (1) month operation of the project. Their Cash Advances for any given month shall not exceed SEVEN HUNDRED THOUSAND (P700,000.00) PESOS.

As Special Disbursing Officers, they shall be guided by the existing accounting and auditing rules and regulations regarding the disbursement of funds which will be entrusted to them by virtue of this designation and shall immediately liquidate the same when no longer needed.

All expenses that will be incurred by the above personnel in connection with the performance of their duties as Special Disbursing Officers shall be chargeable against the allotment of the Upland Stabilization Project-Palawan Integrated Area Development Project subject to the availability of funds and to usual accounting rules and regulations.

This Order supersedes, cancels, revokes all other Memoranda inconsistent herewith specifically DENR S.D. No.644 dated 26 October 1987 and S.O. No. 156 dated 14 February 1989, and shall take effect immediately until revoked in writing.
