SUBJECT:

AUTHORIZING THE ATTENDANCE/PARTICIPATION OF SELECTED PROJECT MANAGERS OF THE DENR IMPLEMENTED AND CONTRACTED AGROFORESTRY AND REFORESTATION PROJECTS OF THE RAINFED RESOURCES DEVELOPMENT PROJECT (RRDP) IN THE CROSS-VISIT AT THE RRDP-MANGROVE REHABILITATION AND COASTAL MANAGEMENT PROJECT IN CANDIJAY, BOHOL ON JULY 23 -29, 1989.

Considering the varied uses of mangrove can offer, the species found therein, ecologically, are sentinels of shorelines, streambanks and tideways, beside being a rich spawning ground/habitation of marine life. The profuse stiltroots break up storm waves while the debris filter the sediments thereby stabilizing the lands.

Most of the reported 139,000 hectares of existing mangrove areas are already degraded and needing immediate attention/rehabilitation. It is in this context that RRDP is giving emphasis on the M & E System. It does not mean RRDP will only benefit but the National Forestation Program as a whole.

In this connection and in the interest of the service, the following Project Managers of the DENR implemented and contracted projects of the Rainfed Resources Development Project (RRDP) are hereby authorized to participate in the cross-visit to the RRDP-Mangrove Rehabilitation & Coastal Management Project in Bohol.
