SUBJECT:

Authorizing the holding of an Executive Conference of all Chiefs of Surveys Divisions in the DENR and the attendance of Key Fersonnel thereof.

- 1. In order to provide a forum for the assessment of the performance of the Central and the Regional Surveys Divisions, the identification of the problem areas, and the adoption of solutions, relating the various aspects of surveying and mapping to the Agrarian Reform Program, the Accelerated Cadastral Survey Program, the Integrated Social Forestry project, and the foreign-assisted projects of the Department; generation of adequate and meaningful awareness and greater appreciation and fuller knowledge of the administrative direction and policy thrust of the administration; to enable them to discuss problems and relate better the surveying and mapping activities with other programs of the department; to commonize their understanding, interpretation and implementation guidelines, design, and standards with the implementors and shall have been more efficient and effective in the implementation of the government development program, an Executive Conference of the key officials of the Surveys Divisions is hereby authorized to be held under the auspices of the Lands Management Bureau.
