SUBJECT: Conduct of an Assessment and Evaluation

Dialoque/Workshop on DENR Foreign-assisted

Projects Performance on 24-25 August 1989

In the interest of the service and in order to improve and to strengthen the implementation, coordination, monitoring and supervision of DENR foreign-assisted projects at all levels, a workshop on foreign-assisted project (FAPs) is hereby authorized to be conducted on $\underline{24-25}$ August at Laoag, Ilocos, Norte.

The objectives of the Workshop are as follows:

- 1. To provide an opportunity for an interaction among workshop participants (particularly Project Managers/Directors, Regional Executive Directors, DENR decision-makers and representatives from concerned agencies) on the assessment of CY 1988 FAPs performance prepared by the Desk Officers, based on field visits and reports submitted by Project Offices.
- To emphasize to the REDs/Regional Offices their responsibility/accountability in the implementation and supervision of FAPs;
- To inject cost-effectiveness considerations in the FAPs implementation;
- 4.:To enhance awareness of the DENR top management on the activities and issues relating to FAPs including the requirements for budget preparation;
- 5. To identify resource gaps in relation to the requirements of the Department; and
- To fine-tune the present reporting and feedback system of FAPs.

The officials and employees whose names are indicated in the hereto appended list, are hereby authorized to attend said workshop.

The Workshop Schedule of Activities is hereinafter attached as Annex A.

Travelling and other expenses shall be charged against the funds of their respective offices and subject to the usual accounting and auditing rules and regulations. Expenses for catering, accommodations and other incidental costs shall be equally shouldered by the participating projects and FASPO.
