Subject: Creation of Non-Governmental/
People's Organization Desk

1. In the interest of the service and pursuant to the thrust of the Department to actively involve non-governmental organizations, as well as, people's organizations in its programs and in the formulation of its policies, a Non-Governmental/People's Organization (NGO/PO) Desk is hereby created, with an Advisory Committee composed of the following:

2. The Advisory Committee, shall be composed of the following:

3. There shall be three coordinators to assist the Desk in the implementation of its work, consisting of:

Coordinator for Field Operations	Samuel Paragas Supv. Mining Engineer Luzon Field Operations
Coordinator for PPMO/FASPO	Irene Lorenzo ERS, Planning Policy Studies Service
Coordinator for Bureaus and attached agencies	Gigi Dioquino EMB

4. The Desk shall have the following objectives:

- a. to serve as coordinating center between DENR programs and NGOs/POs;
- b. to identify NGOs/POs, classify them and authenticate those that are developmental and people-oriented;
- c. to disseminate or make available to NGOs/POs such information about DENR policies, programs and projects;
- d. to tap NGO/PO potential and resources for better delivery of DENR services to actual and direct beneficiaries;
- e. to maintain a working relationship between DENR and NGO/PO, especially in the evaluation and monitoring activities;
- f. to come up with DENR policy guidelines on NGO/PO accreditation, participation and cooperation;
- g. to help in the expansion of NGO/PO participation in DENR programs, policy-making and monitoring activities;
- h. to coordinate with other government agencies in relation to NGO/PO work.

5. To meet these objectives, the Desk is hereby authorized to seek the assistance of any official or employee of the concerned offices.

6. Expenses incurred by the Desk in connection herewith shall be charged against their respective offices, subject to the usual accounting and auditing regulations.

7. This Order shall take effect immediately.
