SUBJECT: Creating Composite Teams to evaluate
the timber resources within areas under
Timber Production Sharing Agreement and
a Monitoring and Review Team.

1. In the interest of the service and pursuant to DENR Memorandum Order No. 12 dated 22 December 1987, Composite Teams are hereby created to evaluate the timber resources within areas under Timber Production Sharing Agreement (TPSA) assigned to them. The teams shall be composed of personnel from the Forest Management Bureau, DENR Regional/Provincial and Community Environment and Natural Resources Offices concerned and representative of Non-Government Organizations (NGO) are as follows:

2. The concerned Regional Executive Director and President Non-Government Organization shall designate their representatives to the teams.

3. The teams shall evaluate the timber resources within the concession area of TPSA holders in accordance with Section Nos. 3 and 4 of DENR Circular No. 04, Series of 1989.

4. They shall avail of the services of any field personnel and facilities necessary to carry out the evaluation.

5. They shall be entitled to reasonable transportation expenses, per diems and other incidental expenses subject to the usual accounting and auditing rules and regulations, chargeable against FMB, Region/PENRO, CENRO and NGO Funds.

6. The teams are authorized to hire two (2) laborers for each team member to assist them in the conduct of the timber resources evaluation.

7. Each team shall submit a report to the Undersecretary, Field Operations, thru the FMB Director, within ten (10) days upon completion of their field work.

8. A Monitoring and Review Team, likewise, is hereby created to be composed of the following:

9. The Monitoring and Review Team shall supervise, evaluate and analyze reports submitted by the composite teams. It shall also prepare comments/recommendations based on submitted reports for submission to higher officials concerned.
