SUBJECT : **Creating Composite Teams to evaluate the timber resources within areas under Timber License Agreement (TLA) and Monitoring and Review Team.**

1. In the interest of the service and pursuant to DENR Memorandum Order No. 12 dated 22 December 1987, Composite Teams are hereby created to evaluate the timber resources within areas under expiring Timber License Agreement (TLA) assigned to them in preparation for their conversion under the Timber Production Sharing Agreement (TPSA) scheme. The teams, composed of personnel from the Forest Management Bureau, concerned DENR Regional Offices/Provincial Environment and Natural Resources Offices, Community Environment and Natural Resources Offices, Office of the Secretary and representatives of Non-Governmental Organizations (NGOs) are as follows:

2. The concerned Regional Executive Directors and the Presidents of the Non-Governmental Organizations shall designate their representatives to the teams.

3. The teams shall avail of the services of any DENR field personnel and facilities necessary to carry out the evaluation.

4. They shall be entitled to reasonable transportation expenses, per diems and other incidental expenses subject to the usual accounting and auditing rules and regulations, chargeable against FMB, Region/PENRO, CENRO, DENR-OSEC and NGO funds.

5. Each team is authorized to hire two (2) laborers per team member to assist in the conduct of the timber resources evaluation, subject to availability of funds and to the usual accounting and auditing rules and regulations.

6. Each team shall submit a report to the Undersecretary, Field Operations, thru the FMB Director, within ten (10) days upon completion of their field work.

7. A Monitoring and Review Team, likewise, is hereby created to be composed of the following:


