SUBJECT: Creation of a Transition Management Committee (TMC) for the Tamaraw Conservation Program (TCP).

In the interest of the service and in view of the termination of the management services of CMAF, Inc. for the TCP and the transfer of its management to UFLB Foundation, Inc. (UPLEFI), a Transition Management Committee (TMC) for the TCP is hereby created to be composed of the following:

- 4. Mr. Horan Bayangan, CENRO, San Jose Member
- 5. Mr. Avelino Garcia, CaNAO, Sablayan Member
- 6. Mr. Vivencio Mitra, CENRO, Sablayan Hember

The Committee shall be responsible for the management of the TOP during the transition period until March 31, 1990 or as soon as Urlawi has fully taken over;

The Committee shall orient/reorient all project personnel absorbed by the new management of employee arrangements and new project directions in the light of the management transfer; final inventory and turn-over of Tor facilities and equipment; regular monitoring of activities in the Mindoro project; and ensure full implementation of all rules and regulations pertaining to the conservation of the tamaraw and its habitat;

The Committee shall submit monthly progress and accomplishment reports and recommendations concerning TOI management to the Director, PAND;

The Committee Chairman is authorized to sign papers/ correspondence and recommendations concerning TCP personnel and other administrative matters pertaining to TCI operations.

The Committee is authorized to avail itself of the assistance/services of any employee of the Department and/or any of its Bureaus and Offices in the pursuance of its tasks;

All maintenance and operating expenses, except for transportation expenses and per diems of DENR personnel in the TMC, which shall be incurred in the management of the TCP shall be chargeable against TCP funds;

The DENR Committee members are entitled to reasonable travelling expenses and per diems chargeable against funds of their respective offices, subject to availability of funds and existing auditing rules and regulations;

This Order take effect immediately and cancels, revokes or amends orders or instructions inconsistent herewith.
