- 5. The above allowances and allowable expenses shall be chargeable against the regional allotment.

SCHOLARSHIP CONTRACT

KNOW ALL MEN BY THESE PRESENTS:

- I, Ricardo C. Soriano, Filipino, of legal age, and presently employed at the DENR as Forestry Supervisor I with assignment at Region II, in consideration of a Scholarship Grant at the National Engineering Center, for me to undergo training on Applied Geodesy and Photogrammetry, from October 30, 1989 to March 1990, inclusive, do hereby agree to the following terms and conditions:
 - 1. The Department of Environment and Natural Resources, Region II, shall pay my school expenses as well as my allowance of one thousand pesos (P1,000.00) a month during the period of my attendance at the National Engineering Center, U.P., Diliman;
 - 2. That I shall attend my classes regularly, comply with all the requirements of the course (academic and practicum), finish it within the period prescribed by the school curricula, observe and abide strictly by all the rules and regulations of the school, and the DENR and render such service as may be required by the Department when not engaged in any actual study;
 - 3. That the DENR may terminate this scholarship agreement any time I fail to live up to the standards as required by the school and the DENR, or any of its bureaus and agencies, or when the funds for the purpose are no longer available;
 - 4. That I shall report immediately to my official station upon the completion or termination of my scholarship and continue to serve in the Department or its bureau or agency for a period of not less than two (2) years for every year or a fraction thereof of not less that two (2) months of scholarship, extended to me under this contract;
 - 5. That I shall submit to the DENR a periodic report on my academic progress and final written report on my studies, training and recommendation within thirty (30) days after my return to duty;



- That I shall refund or reimburse in full to the DENR all the expenses incident to my scholarship in the event of my resignation, voluntary retirement or other causes within my control, or failure on my part to comply with any of the foregoing terms and conditions through my fault or willful neglect, it being understood that proportionate refund shall in no case be allowed; and
- 7. That I shall live up to all other terms and conditions of the scholarship grant.
