SUBJECT: DESIGNATING THE PROJECT FIELD OFFICER AND ASSISTANT FIELD OFFICER OF THE COMMUNITY BASED FOREST MANAGEMENT AND LIVELIHOOD COMPONENT OF RP-GERMAN DIPTEROCARP (DFM) PROJECT IN NAGTIPUNAN, QUIRINO AND THE CHIEF, SOCIAL FORESTRY UNIT AT PROJECT CENTRAL OFFICE, DILIMAN, QUEZON CITY

1. In the interest of the service and in order to effectively implement the Community-based Forest Management and Livelihood Component of the RP-German Dipterocarp Forest Management (DFM) Project at Nagtipunan, Quirino and the project head office, the following personnel/officials are hereby designated:
 - Mr. Romulo Jasmin (Forest Guard of CENRO - Field Officer
Nagtipunan, Quirino)
 - Mr. Loreto Gapus (Forest Guard of CENRO - Assistant Field Officer
Nagtipunan, Quirino)
 - For. Silvestre C. Soriano, Jr. - Chief, Social Forestry Unit
2. As Field Officer, Mr. Jasmin shall perform the following functions in close coordination with the Project Manager and his duly authorized representatives and German Counterparts:
 - 2.1 Organize, implement, monitor and control the activities of the Community Forest Management and Livelihood Component of the Project in accordance with the approved development plan;
 - 2.2 Make recommendations for the effective administration and management of the Project component at Nagtipunan, Quirino;
 - 2.3 Carry out planned training/workshops and public relations work in the community;
 - 2.4 Prepare and submit periodic and annual reports regarding the activities of the Community-based Forest Management and Livelihood Component of the Project to the Project Director and/or authorities concerned; and
 - 2.5 Perform other works that maybe assigned by the Project Manager and his duly authorized representatives, including the German Counterparts.
3. As Assistant Field Officer, Mr. Gapus shall assist the Field Officer in the implementation of the activities of the Project as directed by authorities concerned and in accordance with approved development plan.

4. Forester Soriano, Jr. shall perform his assigned tasks relative to social forestry activities in close coordination with the Project Manager and the German Counterparts.
5. Upon receipt of this Order, Mr. Jasmin, Mr. Gapus and For. Soriano, Jr. shall clear themselves of all work property and financial accountabilities from their present assignment and report for duty to the Community-based Forest Management and Livelihood Component and the Social Forestry Unit, respectively, of the RP-German Dipterocarp Forest Management (DFM) Project, informing this Office thru the Assistant Secretary for Foreign Assisted and Special Projects of their compliance hereof.
6. The above personnel shall be entitled to transportation, and other allowances allowable under existing laws, rules and regulations, subject to accounting and auditing rules and regulations.
7. This Order takes effect immediately.
