All expenses except travelling allowances to be incurred relative to the conduct of said workshop shall be chargeable against FSP-PMO of the Department of Agriculture.





Travelling expenses shall be chargeable against FSP-DENR Component subject to availability of funds and the usual Accounting and Auditing rules and regulations.
