YEAR END EVALUATION AND STRATEGIC PLANNING WORKSHOP December 16-17, 1991 DENR Training Center, Diliman, Q.C.

Rationale and Objective

The Integrated Social Forestry Program had gone another year of implementation. However, the approval of the Local Government Code will greatly affect the program since it has to be devolved to the Local Government Units.

To ensure the smooth turnover of the program, different strategies and mechanisms for devolution need to be discussed. Also assessment of status of ISF projects have to be undertaken to determine what projects can be devolved to the community. To discuss these mechanisms, a year end evaluation and strategic planning activity will be held on December 16-17, 1991 at DENR Training Center, Diliman, Quezon City. Its primary objective will be to evaluate ISF performance and accomplishments, identify thoroughly the functions and activities to be under-taken by the Division for 1992 and the succeeding years, hence, the proposed workshop.
