SUBJECT : Creation of an Inter-Agency Committee to Evaluate Wildlife Permit Applications and Allocation of Quota.

In view of DENR Administrative Orders No. 90, dated 22 November 1988, and No. 96, dated 19 December 1988, and in order to expedite the allocation of the annual quota for the collection and exportation of Philippine wildlife resources, an Inter-Agency Committee is hereby created composed of the following:

The Committee is hereby tasked with the following functions, duties and responsibilities:


- 1) Evaluate and assess the over-all performance of permittees, including their holding and breeding facilities;
- 2) Determine the sound bases for allocating the yearly national quota among the qualified permittees;
- 3) Determine the yearly national quota for species listed in Appendices II and III of the CITES and those wildlife species not listed therein which may still be allowed for trade;
- 4) Determine the allowable quota for wildlife to be devoted to the captive-breeding program of each qualified permittee; and
- 5) Prepare and submit appropriate recommendations and resolutions to the Secretary relative to the foregoing matters.
