The above personnel shall be at Magdugao, Passi, Iloilo on January 28, 1991 in time for the start of Phase I of the training. On February 9, 1991, they shall leave Iloilo City for Metro Manila for official briefing at the National Coordinating Office for ISFP, and shall proceed to College, Laguna and be at the NTCRD on February 13, 1991 for Phase II of the training.

They shall be entitled to reasonable transportation expenses from their respective stations to Magdungao, Passi, Iloilo, to Metro Manila then College, Laguna, and back to their places of assignment, and reasonable travel expenses for the period from February 10-12, 1991 while on official business in Metro Manila, chargeable against the appropriation of their respective offices/units subject to availability of funds and existing COA regulations.

The Regional Executive Director, Region VI, shall designate two personnel to serve as members of the Training Secretariat for the duration of the training at Magdungao, Passi, Iloilo.

Expenses for board and lodging and other training expenses shall be shouldered by the FAO-TSARRD.

This Order shall take effect immediately.
