SUBJECT: DESIGNATION OF GEODETIC ENGR. IV JESUS C. PERILLA AS ASST. PROJECT MANAGER FOR THE NORTHERN SECTOR, SUPERVISING LAND MANAGE-MENT OFFICER VICENTE F. SENORIN AS ASST. PROJECT MANAGER FOR THE SOUTHERN SECTOR AND PEO III ARVIN S. FLORES AS PROJECT MONITORING AND EVALUATION OFFICER OF THE SURVEY AND LAND TITLING COMPONENT UNDER THE SECOND PALAWAN INTEGRATED AREA DEVE-

LOPMENT PROJECT.

In the interest of the service, Messrs. Jesus C. Perilla, Vicente F. Senorin and Arvin S. Flores are hereby designated as Asst. Project Manager for the Northern and Southern Sector and Monitoring and Evaluation Officer respectively, of the Survey and Land Titling Component under the Second Palawan Integrated Project.

- 2. As Asst. Project Managers for Northern and Southern Sector, Mr. Perilla and Mr. Senorin shall be under the supervision of the Project Director and shall perform the following functions:
  - a) Assist the Project Director in supervising the implementation of Project activities relating to Surveys and Titling in accordance with the approved Work and Financial Plan;
  - b) Assist the Project Director in the establishment of schemes and procedures for effective and efficient project implementation consistent with the operational framework for foreign-Assisted Projects and other agency regulations, guidelines and procedures;
  - c) Assist the Project Director in the review and implementation in accordance with the duly approved implementation/development plan, the project's periodic work and financial activities covering their respective sector;
  - d) REcommend Travel Orders and Itineraries of Travels of personnel detailed/assigned in their sector for periods not exceeding fifteen (15) days a month subject to the approved Travel Plans;
  - e) Perform related tasks as may be assigned by the Project Director and higher authrorities.
- As Project Monitoring and Evaluation Officer of the Survey and Land Titling Component, Mr. Flores shall be under the supervision of the Project Director and shall perform the following functions, thus:
  - a) Assists the Project Director in monitoring the activities of the Survey & Land Titling groups for northern and southern sectors in relation to the prompt submission of accomplishment reports and the attainment of planned work goals;



- b) Consolidates submitted accomplishment reports and initiates the preparation of base maps for compilation and control and updates the Land Resource Information (LRI) for statistics purposes;
- c) Coordinates and facilitates project activities relative to mapping and other technical work in the Land Management Sector, Region IV, DENR Quezon City; NAMRIA, Fort Bonifacio, Makati, Metro Manila and other concerned agencies;
- d) Spearheads the review, assessment and evaluation of the performance of the titling and survey groups relative to the prompt attainment of work goals;
- e) Performs such other functions that may be assigned/ delegated by the Project Director and higher authorities.
- 4. Messrs. Perilla and Senorin shall establish a sub-sector office of their component and be based on their respective sectors in Palawan.
- 5. This Order shall not entitle Messrs. Perilla, Senorin and Flores to preferential rights to promotion.
- 6. All authorized expenses incurred by the above-mentioned personnel are chargeable to DENR-Survey & Land Titling Component/PIADP funds subject to availability and usual accounting and auditing requirements.
- 7. This Order takes effect immediately and cancels/supersedes all previous Orders, Memoranda and/or Letters inconsistent herewith.
