SUBJECT :

ORGANIZING A STEERING COMMITTEE. NATIONAL STUDY GROUP. REGIONAL COMMITTEE AND JOINT STUDY TEAM TO IMPLEMENT THE PROVISIONS OF LOI 1258 AND ADMINISTRATIVE ORDER NO. 47 DATED 17 MAY 1990

RESPECTIVELY.

In line with the continuing need to effectively implement LOI 1258 and with further reference to DENR Administrative Order No. 47 dated May 17, 1990 which mandated the re-examination and inventory of all existing reservations, a Steering Committee, Regional Committee, National Study Group and the Joint Study Team in each of the 14 Regions are hereby organized to be composed of the following:

A. The Steering Committee shall be composed of the following:

Chairman - - - - - - - USEC for Field Operations
Vice-Chairman - - - - - - Director, LMB
Members - - - - - - - Director, FMB
Director, EMB
Director, MGSB
Administrator, NAMRIA
Representative from agency
whose reservation are being
examined.

FUNCTIONS:

- 1. Formulate guidelines and regulations for the effective implementation of the project.
- 2. Recommend revocation or amendment of orders or proclamations covering a reservation whenever warranted.
- 3. Review reports and records of each reservation.
- 4. Provide overall planning, organization and monitoring of the project activities.
- 5. Prepare final report to the Secretary.

B. National Study Group

The National Study Group shall be headed by the Chief, Land Utilization and Disposition Division, who shall be the Project Coordinator, with the following as members:

Chief, Legal Division, LMB

Chief, Surveys Division, LMB

Chief, PPMSD, LMB

Chief, Records Division, LMB

Chief, Real Property Management Division, LMB

One (1) Representative from the OSEC

One (1) Representative each from FMB, NAMRIA, MGSB, EMB as may be designated by their respective Bureau Directors

Five(5) Project officers, as may be designated by the Director, LMB

FUNCTIONS:

- 1. Recommend measures and strategies to ensure smooth flow and continuity of operations to attain objectives.
- 2. Prepare work programs and schedule.
- 3. Monitor progress of activities.
- 4. Prepare executive reports with recommendation to the Steering Committee, and drafts of the corresponding proclamations disestablishing or amending any reservations and reserving the land embraced therein or portions excluded thereon for other government project purposes.
- 5. Provide the necessary technical, legal and administrative staff support to the functions and activities of the Committee.
- 6. Serve as Secretariat of the Steering Committee.
- C. Regional Committee

The Regional Committee shall be composed of the following:

Regional Coordinator - - - - - Regional Executive Director

Deputy Regional Coordinator - - - Regional Technical Director for Lands

Provincial Coordinator - - - - PENR Officer

Municipal Coordinator - - - - CENR Officer

whose reservation are being examined

Three (3) Action Officers as may be designated by the Regional Executive Director

Two (2) Clerical Staff.

FUNCTIONS:

- 1. Monitor, evaluate and review reports of the Joint Study Team for subsequent transmittal to the National Study Group.
- 2. Submit periodic reports, comments and recommendations to the National Study Group on the reservations investigated.
- 3. Decide at its level and recommend to the Steering Committee, in consultation with the agencies concerned, the proper disposition of the reservations under review.
- 4. Supervise the preformance of the Joint Study Team with a view to expediting and effectively carrying out the inventory and investigation work.

D. Joint Study Team

The Regional Executive Director shall be authorized to organize a Joint Study Team for every PENR Office and CENR Office. It shall be headed by a Project Leader and complemented by a Clerical Group and Technical Group.

FUNCTIONS:

- Conduct nationwide inventory and investigation of existing reservations.
- 2. Coordinate with the proper agencies in whose favor reservations have been established.
- 3. Prepare write-ups and recommendations of reservations together with the corresponding sketch maps properly indicating the affected areas, for possible revocation or amendment of the corresponding executive orders/ proclamations.
- 4. Execute the necessary survey to determine the area to be segregated in case the recommendation is to amend the executive order/proclamation.
- 5. Prepare and submit write-ups/reports using the prescribed format under Administrative Order No. 47 to the Lands Management Bureau.

This Order revokes Special Order No. 111 dated February 15, 1991.

This Order is for the good of public service and shall take effect immediately.
