
2. Each team should verify, assess, and evaluate the suitability of recommended CFP sites based on guidelines in DENR Administrative Order No. 123, series of 1991. Accordingly, each team should submit to the CFP Secretariat a detailed schedule of field visits to each assigned CFP site.
3. Team leaders and members from the DENR Central Office will be required to attend a scheduled briefing for all site verification and evaluation teams. The CFP Secretariat will inform each team about the details of the briefing at least one week before scheduled site visits.
4. During the field verification and site evaluation process, all teams are instructed not to involve any non-government organizations (NGOs). The teams should maintain their independence in order to minimize future complications in selecting CFP-recipient NGOs.
5. Each team will present their findings and recommendations during a site verification and evaluation workshop which will be scheduled at least a week after the last field visit.
6. After the sites are selected, the teams will prepare terms of reference (TOR) for the CFP sites which they have visited. All the draft TORs should be submitted to CFP Secretariat for final revision and distribution to DENR Regional Offices and pre-qualified NGOs.
7. All expenses incurred in the performance of work, duties, and responsibilities shall be charged against the DENR/NPCO/CFP Fund subject to usual accounting and auditing rules and regulations.
8. This Order will take effect immediately and shall be terminated upon completion of the assigned tasks.
