SUBJECT: Creation of a Technical Working Group for

the Implementation of DENR/EMB Sectoral Commitment on Local Development Assistance

Program.

Pursuant to the commitment of the Philippine Government with the USAID under the Grant Agreement on Local Development Assistance Program, the DENR shall, in general, pursue its decentralization efforts and, in particular, improve the capability of Local Government Units (LGUs) on environmental planning and monitoring through the development and implementation of training programs for the LGUs.

To carry out said endeavor, a Technical Working Group (TWG) is hereby created at DENR, composed of the following:

The TWG shall be responsible for the following as part of DENR's commitment under said Grant Agreement on LDAP:

- 1. Fine-tuning of, Framework Action Plan for the training of LGUs, earlier drafted by the EMB.
- 2. Formulation of guidelines in the selection/prioritizing of LGUs to be piloted under the LDAP-DENR/EMB component.

- Assessment of capabilities of LGU's and collection of other relevant baseline information.
- 4. Identification of ways and means of cooperation with DILG-LGA (Local Government Academy) and other agencies.
- 5. Formulation of Training Program and detailed design.
- 6. Facilitate and coordinate the preparation and conduct of trainings in the pilot LGUs.
- 7. Facilitate and coordinate the identification of study areas for policy proposals; initial screening and subsequent submission of said proposals to NEDA-USAID under the Program's technical assistance component.

The TWG shall prepare a Workplan indicating details of work requirements and responsibility centers which will serve as the blueprint for its operations.
