SUBJECT : Creation of a Philippine Eagle Conservation Program Management Committee (PECPMC) replacing the Philippine Eagle Conservation Program Steering Committee (PECPSC).

In the interest of the service and in view of the DENR thrust towards an integrated Philippine Eagle Conservation Program (PECP) to ensure the continued survival of the endangered Philippine Eagle, a Philippine Eagle Conservation Program Management Committee is hereby created to replace the Philippine Eagle Conservation Program Steering Committee to be composed of the following:

A Secretariat for the Committee is also hereby created composed of the following:

2. Ms. Leonarda Buenaventura, PAWB - Member

The Committee shall continue to prepare a comprehensive and integrated conservation plan for the Philippine Eagle; shall provide direction and sustain impetus for the growth and implementation of the Program; shall conduct periodic monitoring, review and evaluation of the various activities of the Program; and shall provide working coordination and effective communication between and among the agencies/organizations of the PECP.

The Committee is authorized to form sub-committees on field research, captive breeding, conservation education and other areas of concern as may be needed.

The Committee is authorized to avail itself of the assistance and services of any employee of the DENR in the performance of its tasks and functions.

The Committee shall report to the Undersecretary for Environment and Research through the Director, PAWB.

The Secretariat shall provide administrative support, undertake liaison work for the Committee, prepare schedules of Committee meetings, and record the minutes/proceedings and Committee recommendations.

The members of the Committee, Sub-Committees and Secretariat are entitled to reasonable travelling expenses and other expenses incurred in the performance of its tasks, chargeable against PECP funds, and subject to availability of said funds and to the usual accounting and auditing rules and regulations.

This Order takes effect immediately and revokes DENR Special Order No. 05, s. 1990 and its amendments.
