

SUBJECT: CHANGE IN TITLE OF POSITIONS

In the interest of the service and pursuant to DENR Special Order No. 91 Series of 1991 which designates **Mr. JUANITO D. LAMANILAO** as Acting Program Coordinator and **Ms. EDNA R. SARMIENTO** as Assistant Program Coordinator, their designation titles are hereby amended and will now be Acting Project Manager and Assistant Project Manager respectively. SUBJECT: Designation of Officers at NPCO/NFP


