SUBJECT: Addendum to DENR Special Order No. 31 Series of 1990 as amended.

1. In the interest of the service and in order to effectively hasten the implementation of Department Circular No. 03, Series of 1990 as amended, relative to the acceptance, identification, evaluation and delineation of ancestral land claims within Baguio City and the rest of the Cordillera Provinces, the membership of the Special Task Force created thereunder is hereby increased and reorganized as follows:

2. The Task Force shall be divided into four (4) divisions, with each division headed by a Vice-Chairman who shall be its presiding officer as follows:

3. The Task Force sitting en banc shall among others investigate, deliberate and resolve applications for community, tribe or barangay applications where the beneficiaries exceed one thousand (1,000) families. Individual, family, clan or barangay applications shall be raffled by the Chairman to the four (4) divisions for investigation, deliberation and resolution, provided that nothing in these provisions shall be construed as a diminution of the authority of the Task Force sitting en banc to investigate, deliberate and resolve any application.
4. The Chairman shall, subject to existing policies, rules and regulations on the project and directives from the Office of the Regional Executive Director exercise administrative supervision of the Task Force and in his absence, any one of the Chairmen shall be ~~designated~~ *designated* by the RED to run the day to day affairs of the Office.
5. In case of absence of any member of any division, the



Chairman, upon written request by the Presiding Officer thereof shall designate any member to sit in the said division, provided that whether sitting en banc or in the division, a simple majority thereof is sufficient to transact business;

6. There is hereby created in every CENR Office through DENR-CAR, as part of the Task Force a three (3) man committee whose membership is to be nominated by the PENRO and CENRO concerned and designated by the Regional Executive Director whose functions shall be the following:
 - a. Deliberate and pass upon all investigation reports of ancestral land claim applications in their respective areas of jurisdiction and submit the same for review to the Task Force thru the CENRO and PENRO.
 - b. Perform such other functions assigned to it by the Task Force and the Regional Executive Director.

provided, that all applications in the City of Baguio shall be investigated, deliberated and resolved by the Task Force.

This order shall take effect immediately and supercedes/amends all orders/memoranda inconsistent herewith.
