SUBJECT :

Creation of Pre-Inventory Evaluation Committee, Monitoring and Evaluation Committee and Inventory Secretariat pursuant to DAO 24 and DMO 08, both series of 1991.

Pursuant to the provisions of DENR Administrative Order (DAO) No. 24 and DENR Memorandum Order (DMO) No. 08, both series of 1991, shifting logging from the old growth (virgin) forests to the second growth (residual) forests a Pre-Inventory Evaluation Committee, Monitoring and Evaluation Committee and Inventory Secretariat are hereby created to evaluate the second growth in forests in TLA/TPSA areas with the following membership and functions:

## 1. PRE-INVENTORY EVALUATION COMMITTEE (PIEC)

- 1.2 The specific functions of the PIEC are:
  - 1.2.1 Evaluate the extent of the operable second growth forests by Management Block in TLA/TPSA concession areas based from the maps submitted by the DENR Regional Office.
  - 1.2.2 Prepare reports for the DENR Secretary about the TLAs/TFSAs that shall be subjected to 10% strip the sampling based from the results of the evaluation specified in item 1.2.1.

  - 2.2.2 Evaluate the timber inventory reports that shall be submitted by the CFITs together with the appropriate recommendation based from the results of such inventory surveys.

- 2.2 The specific functions of the IS are:
  - 2.2.1 Prepare the initial blocking of the residual forests of TLA's indicating areas 26 yrs. & older and those that are younger.
  - 2.2.2 Assist the PIEC, CFITs and MEC in the preparation/evaluation of the soil cover maps of TLAs/TPSAs.
  - 2.2.3 Prepare initial analysis of the reports that shall be submitted by the CFITS.
- 4. All expenses that shall be incurred by the PreInventory Evaluation Committee (PIEC), Monitoring and Evaluation Committee (MEC) and Inventory Secretariat (IS) incidental to the pre-inventory evaluation of the second growth forests in TLA/TFSA areas shall be charged against the trust fund deposits of the licensees, subject to the usual government accounting and auditing regulations.
- 5. This Order shall take effect immediately.
