

4. Under this Order also, they are required to:
- sign a scholarship contract with the DENR within thirty (30) days from the opening of classes;
  - abide by the terms and conditions of the DENR Scholarship Contract and the Policy Guidelines on Local Scholarship;

c. report immediately to their respective official station after completing the Course/Grant and to submit a Certification form immediate supervisor of the day he/she has reported back to duty; and

5. This Order takes effect immediately and remains in force until the completion of the Course/Grant or until such grant is terminated as the case may be.
