SUBJECT: Deputizing members of the Nagkakaisang Tribu
ng Palawan as Forest Officers of the
Department of Environment and Natural
Resources.

1. Pursuant to the provisions of Presidential Decree No. 705, as amended, the following members of the Nagkakaisang Tribu ng Palawan (NATRIPAL) are hereby deputized as Forest Officers of the DENR effective upon receipt hereof, of which this Office shall be informed accordingly, to wit:



2. By virtue of this deputation, they are authorized to detect/investigate violations of forestry laws, rules and regulations and to arrest even without warrant any person who has committed, is committing or is about to commit in their presence any of the offenses defined in Chapter IV of Presidential Decree No. 705, as amended, within their territorial jurisdiction.
3. They are authorized to seize/confiscate the tools and equipment used in committing the offense and the forest products cut, gathered or removed by the offender(s) in the process of committing the offense. In all instances of detection, arrest and/or seizure or confiscation, they shall deliver within the period prescribed by law from the time of arrest and seizure, the offender(s) and confiscated forest products, tools and equipment, including the conveyance(s) used and file the proper complaint with the appropriate officials designated by law to conduct preliminary investigation and file the information in court through RED/PENRO/CENRO concerned.
4. They are further authorized to administer oath and take acknowledgement in official matters connected with their aforementioned functions and to take testimonies in official investigations conducted under the authority of the Revised Forestry Code, as amended, and its implementing rules and regulations including the provisions of this herein Order.
5. They shall submit to the Secretary of the DENR thru the RED/PENRO/CENRO concerned a monthly report of the cases they have handled/activities undertaken pursuant to this deputation order.

6. The PENRO, Puerto Princesa City is hereby instructed to conduct a briefing of the herein-deputized forest officers before the latter could discharge their functions mentioned herein.
7. This Order shall expire on December 31, 1991 or until sooner revoked by this Office.
