This Order shall take effect immediately.



4. Coordinate all meetings of the Board.


All expenses that will be incurred by the Board shall be chargeable against DENR funds, subject to the usual Accounting and Auditing rules and regulation.


SUBJECT : Amendment to DENR SO # 704, Series of 1989, RE: Creation of a DENR Project Deliberation Board and Selection Group
