SUBJECT :

Strengthening of the Inventory Secretariat pursuant to the implementation of DAO 24 and DMO 08, both series of 1991.

1. Pursuant to the provisions of DENR Admininstative Order (DAO) No. 24 and DENR Memorandum Order (DMO) No. 08, both series of 1991, shifting of logging from the old growth (virgin) forests to the young growth (residual) forests, the Inventory Secretariat is hereby strengthened to increase its capabilities in the computerization of the data that shall be submitted by the Composite Forest Inventory Teams; the membership, designation and office of the strengthened Inventory Secretariat are as follows:

- 2.3 Validate in the field in coordination with the MEC the accuracy of the inventory data; and
- 2.4 Submit a comprehensive report of data analysis to the Secretary thru the Chairman, MEC and FMB Director for his record and information.
- 3. All expenses that shall be incurred by the above-named personnel in the performance of their functions relative to this Order shall be charged against the trust fund deposit of the TLA holders, subject to the usual government accounting and auditing laws, rules and regulations.
- This Order shall take effect immediately.
