The abovecited personnel shall receive the following monthly rates as per 2nd Indorsement from Malacañang dated June 25, 1979: members of the Evaluation Committee and

Project Coordinator - \$\mathbb{P}400.00; members of the Technical Working Group and its Staff and other advisers - \$\mathbb{P}300.00; members of the Administrative Staff - \$\mathbb{P}200.00.

DENR Regional Office personnel may also be granted monthly honoraria of \$\mathbb{P}300.00\$ on a case to case basis, i.e., when the area under their jurisdiction is involved in the processing of claims for damages. Authority to claim honoraria in this case shall be upon recommendation of the Chairman of the Evaluation Committee.

As in the previous practice, said honoraria and allowance shall be charged against the \$\mathbb{P}300,000.00 alloted annually from the P.D. 1251 reserve fund as provided for such purposes under Section 1 of P.D. 1720.

This order shall take effect immediately.
