
The validation teams shall proceed to the regional offices and brief the Regional Executive Director and other regional key officials on the validation procedures and strategy. The regional offices shall provide all the necessary assistance, accommodations and logistics to the validation teams. Pertinent records, documents and other evidences that may be requested by the teams should be provided to them immediately.

A validation report shall be presented to the Regional Executive Director before the validation team leaves the regional office. The final report shall be submitted to the Undersecretary for Planning, Policy and NR Management two weeks after the validation.


All travelling expenses to and from the regional offices shall be charged against the respective offices of the validators subject to the usual accounting and auditing rules and regulations.
