Deputation of Eleven Personnel of City Agriculturist in Pasonanca. Zamboanga City, as Deputy Environment and Natural Resources Officers (DENROs) of the Department of Enviconment and Natural Resources

Purposent to the pertinent provisions of existing environment and natural resources laws, rules and regulations, the following eleven personnel of City Agriculturist are hereby deputible as Environment and Natural Resources Officers (DENEOR), to exercise the power and authority provided for in the aforestic laws, but and regulations under the supervision of the CENE Officer and cerned effective upon receipt hereof, of which this Office shall be informed accordingly:

By virtue of this deputation, they are Authorized to detect and investigate violations of natural resources laws, rules and regulations, and to appear even without variant any passon who has committed, as committing or is about to commit in their presence any of the original offenses defined under the sale lowers amended within the territorial jurisdiction of the CINES concerned.

They are also suthorized to apprehend, oside the tuble, equipment and conveyences used in the commission of the offence and the natural resources products, extracted/two gathered/removed and possessed by the offender(s) in the product of committing the offence. In all instances of determine, two and/or seizure, they shall deliver within the period pres riber by law from the time of correst and relates the offenders(s) and the seized net took resources products, tooks, equipment and conveyences used, and file the appropriate complaint with the concerned officials designated by law to conduct groundinary investigation and likewise file the information in court through the CENRO/PENRO/SED concerned.

They are forther authorized to administer eath and at take asknowledgment in official masters connected with the business of their office, and to take testimony in official investigations conducted under the authority of the aforesited laws so emenced and their implementing rules and regulations.

Furthermore, they shall assist in the entirement of national resources laws, rules and regulations, and in the consumn of environment and network resources information and obstation campaign such as public meeting assemblied and tuber interview activities of the ISERO concerned in occidination with the officials/personnel and or private agencies involved in cimilar vaca.

They shall submit to the CENRO/PENRO/RED concerned a monthly accomplishment report using the standard reporting form provided by the aforecited DENR A.O.

This deputation authorizes them only to exercise the power and authority conferred herein within the territorial jurisdiction of the CENRO concerned.

This deputation Order takes effect immediately and will expire on December 30, 1993 or unless sooner revoked or terminated by this Office.
