Implementation of DAO No.2 and S.O. No. 25, Re: Ancestral Domain Concepts & Delineation Procedure in Oriental and Occidental Mindoro

Pursuant to the Constitutional Mandate for the recognition and protection of the rights of the indigenous cultural communities (ICCs) to their ancestral lands domains and as a result of the last ADB Mid-Term Review Mission conducted from \$6-20 August 1993 in Occidental and Oriental Mindoro for the Low-Income Upland Communities Project (LIUCP), one of the issues identified is the issue of ancestral lands.
