SUBJECT:

Deployment of Regional Land Evaluation Parties (LEPs). NAMRIA Forest Survey Teams (FSTs) and Global Positioning System (GPS) Crews for the demarcation of the remaining Old Growth (Virgin) Forests in Region 10. Cagavan de Oro City, in accordance with the implementing guidelines as provided for in Department Memorandum Circular No. 14, Series of 1991.

- 1. In the interest of service and in pursuance to the implementing guidelines as provided for in Department Memorandum Circular (DMC) No. 14, Series of 1991, the following survey groups are hereby deployed in Region 10, Cagayan de Oro City to undertake the demarcation of the remaining Old Growth (Virgin) Forest thereat:
 - 1.1 One (1) Land Evaluation Party (LEP) each from the Cordillera Administrative Region (CAR), and Region 1 to 8.
 - 1.2 Three Land Evaluation Parties (LEP) each from Regions 9 to 12.
 - 1.3 Five (5) NAMRIA Forest Survey Teams.
 - 1.4 Five NAMRIA Global Position System (GPS) Crews.
 - 1.5 All Regional LEP Coordinators
- 2. Except for the GPS crew with two (2) technical foresters each survey crew, the Regional LEP and NAMRIA Forest Survey Team shall compose of one (1) Team Leader. Two (2) Forester member and one (1) Cartographer each party/team.
- 3. The GPS Survey Crews shall establish Geodetic Survey Control or Reference Point Network near the periphery of the old growth forest for purposes of tying subsequent surveys.
- 4. The Regional LEPs and NAMRIA FSTs under the immediate supervision of their respective Team Leaders/Coordinators shall be guided with the procedures/methods set forth under Appendices I and II of DMC-14 as well as the related instructions thereof.
- 5. Working areas of the survey teams/crews shall directly come from or designated by the National Secretariat based on the control map showing the compilation of the predetermined Old Growth Forest nationwide.

- 6. Team leaders of survey parties shall submit their corresponding reports thru channel to the National Secretariat, OGF Remote Sensing and Resources Data Analysis Department NAMRIA Fort Bonifacio Makati, for further evaluation, processing/documentation and monitoring purposes.
- 7. Traveling expenses of Land Evaluation Parties and Coordinators shall be charged against their respective offices transmitted for the purpose while other related expenses shall be charged to Region 10 all under ADB Forestry Loan 2.
- 8. The LEP Coordinators of Regions 10, 11 and 12 are designated as Special Disbursing Officers under this project.
- 9. This Order takes effect immediately and remain in force until otherwise revoked in writing.
