The Director of Special Concerns Office is hereby authorized to issue orders and instructions in connection with the aforementioned tasks; maintain direct control, supervision, and shall closely monitor the abovementioned tasks.

The Regional Office concerned including their field units are hereby enjoined to extend full assistance and cooperation to the aforementioned personnel in the pursuit of the tasks assigned to them.

The aforementioned personnel shall submit a spot/initial report as soon as possible, a progress report, and a final report within 10 days after returning from the field or sooner as directed by the Director of the Special Concerns Office.

This Order shall remain valid for two (2) days unless extended by a written order from the Director of the Special concerns Office which must be attached hereof.
