SUBJECT: Authorizing the conduct of Seminar/Workshop on the implementation of DAO No. 02 and S.O. No. 25 both <u>series of 1993 in the Provinces of Quirino and </u> Palawan.

In the interest of the service and in view of the selection of the provinces of Quirino and Palawan as pilot implementation sites of DAO No. 02 and S.O. No. 25, both series of 1993, a seminar/workshop is hereby authorized to be conducted jointly by the Indigenous Community Affairs Division, Special Concerns Office (ICAD-SCO) and the Natural Resources Management Program (NRMP) and to be attended by the following:

- Seminar/Worshop on these provinces shall be attended by six (6) staff from the SCO and NRMP who shall serve as Resource Persons and facilitators.

All expenses to be incurred during the workshop proper shall be charged against NRMP Funds. Travelling expenses of the Central Office Staff shall be charged against their respective offices, subject to the usual accounting and auditing rules and regulations.
