Conduct of Serialized Planning and Budgeting 2, 4, 10 and 11.

- 1. In the interest of t pursuant to the thrust of formulating updated Medium Term ENR Development Plans and responsive and realistic Annual Plans, a series of Workshops to be known as "Serialized Workshop on ENR Planning and Budgeting (SWEPB)" shall be conducted in the 4 Focal Regions of NRMP namely: Region 2, Region 4, Region 10 and Region 11.
- 2. The SWEPB shall aim to:
 - a. Facilitate DENR's planning and budgeting process.
 - Upgrade the planning and budgeting capability of planning officers and finance and/or budget officers of field units; and
 - c. Establish a process-oriented planning and budgeting system of DENR.
- 3. The expected output of the SWEPB shall be as follows:
 - a. Work and Financial Plans for FY 1994
 - b. Revised and/or updated ENR Medium Term Development Plan (1993-1998)
 - c. Provincial-level Medium Term Plan for Forestry Development; and
 - d. Proposed Plan and budget for FY 1995
- 4. The schedule of SWEPB in the different Focal Regions shall be as follows:
 - a. Workshops on ENR Planning and Budgeting to prepare and/or formulate the Work and Financial Plan for FY 1994.

Workshop to revise/update ENR/Forestry Medium Term b. Plans and to formulate the plan and budget proposal for FY 1995.

- personnel shall Consultants and PPSO 6. NRMP RPTS facilitate the technical process and the generation of SWEPB. On the other hand, HRDS of host Regional outputs of Offices shall make the necessary physical arrangements, including the provision of equipment and vehicles.
- The cost of workshop venue and board/lodging of participants 7. shall be borne by the Development Alternatives Inc. (DA1). The cost of supplies and materials shall be shouldered by NRMP. Transport expenses of participating Regional field offices shall be shouldered by their respective units. Travelling expenses of Central Office participants shall be shouldered by their respective units.
- All officials/employees of host Regions are enjoined to give 8. full support to the SWEPB undertakings.

This order shall take effect immediately.
