
SUBJECT : Authorizing the Conduct of A Coastal

COASTAL ENVIRONMENT PROGRAM PLANNING AND REPROGRAMMING WORKSHOP

RATIONALE

The Coastal Environment Program which was established last April 22, 1993, is now in its seventh month of implementation. Considering that the program involved the shifting of policy in the implementation of coastal rehabilitation, there is now a need to assess and review all activities that were undertaken under the program and serve as input in the finalization of the CEP Plan for 1994 and in the formulation a National Framework Plan of the Coastal Environment Program.

OBJECTIVES

1. To review the CEP implementation for CY 1993, including the discussion of problems, constraints, and successes.
2. To define the 1994 CEP Plan, including the identification of priority activities.
3. To institutionalize the role of each CEP unit in the implementation and formalize the organization of CEPCO.
4. To review and approve CEP UWM and KRA.
