SUBJECT : CREATION OF SPECIAL TASK FORCE TO FORMULATE AN OPERATING GUIDELINES FOR COMPREHENSIVE SITE DEVELOPMENT (CSD) AND INCOME ENHANCEMENT PLANTING (IEP) COMPONENT OF FOREST LAND MANAGEMENT AGREEMENT (FLMA).

The Task Force shall perform the following functions:

1. Formulate and recommend policies, guidelines and procedures related to the implementation of the CSD and IEP;
2. Coordinate with DENR field offices, other government agencies and NGOs regarding the proper implementation of CSD and IEP activities adaptable nationwide; and
3. To come up with a systematic methodology and mechanism for CSD and IEP to ensure the proper selection of FLMA holders.

The Task Force shall submit its progress report to the Chairman, NFP Steering Committee thru the NPCO Project Manager.




