
SUBJECT : Authorizing the attendance of DENR-FASPO Personnel to Development Academy of the Philippines (DAP) Training Courses

This Order is effective only for the duration of the corresponding training course.

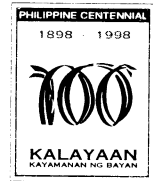
