
The Task Force shall perform the following functions:

1. Formulate and recommend policies, guidelines and procedures related to the implementation of the CBFM;
2. Coordinate with DENR field offices, other government agencies and NGOs regarding the proper implementation of CBFM activities adaptable nationwide; and
3. To come up with a systematic methodology and mechanism for CBFM to ensure the proper selection of CFMA awardees.


The Task Force shall submit its progress report to the Chairman, NFP Steering Committee thru the NPCO Project Manager.

All allowable expenses of the task force shall be chargeable against the NFP funds subject to the usual accounting and auditing rules and regulations.

This order shall take effect immediately unless revoked or amended.
